**G.S.R. 194.**-In exercise of the powers conferred by sub-section (1) of section 25 of the Private Security Agencies (Regulation) Act, 2005 (Central Act No. 29 of 2005), the State Government hereby makes the following rules further to amend the Rajasthan Private Security Agencies (Regulation) Rules, 2006, namely:-

**1. Short title and commencement.**- (1) These rules may be called the Rajasthan Private Security Agencies (Regulation) (Amendment) Rules, 2020.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

**2. Amendment of rule 4.**- In rule 4 of the Rajasthan Private Security Agencies (Regulation) Rules, 2006, hereinafter referred to as the said rules,-

- (i) in sub-rule (2), for the existing expression "District Superintendent of Police", the expression "District Superintendent of Police/Deputy Commissioner of Police" shall be substituted;
- (ii) in sub-rule (3), for the existing expression "The District Superintendent of Police", the expression "The District Superintendent of Police/Deputy Commissioner of Police" shall be substituted; and
- (iii) in sub-rule (4), for the existing expression "The District Superintendent of Police", the expression "The District Superintendent of Police/Deputy Commissioner of Police" shall be substituted.

**3. Amendment of rule 5.**- In rule 5 of the said rules,-

- (i) in sub-rule (2), for the existing expression "District Superintendent of Police", the expression "District Superintendent of Police/Deputy Commissioner of Police" shall be substituted; and
- (ii) after the sub-rule (2), so amended, the following new sub-rule (3) shall be added, namely:-  
"(3) No Licence shall be granted to any agency, Partnership Firm or Company has a name in which words like Detective , Investigation, Surveillance, Intelligence, Interrogation, Facility, Labour Supplier etc is included.

**4. Amendment of rule 7.**- In rule 7 of the said rule,-

- (i) in clause (c) of sub-rule (1), for the existing expression "District Superintendent of Police", the expression "District Superintendent of Police/Deputy Commissioner of Police" shall be substituted;

- (ii) in sub-rule (3), for the existing expression "District Superintendent of Police", the expression "District Superintendent of Police/Deputy Commissioner of Police" shall be substituted; and
- (iii) in sub-rule (5), for the existing expression "District Superintendent of Police", wherever occurring, the expression "District Superintendent of Police/Deputy Commissioner of Police" shall be substituted.

**5. Amendment of rule 13.-** In clause (v) of rule 13 of the said rules, for the existing expression "District Superintendent of Police", the expression "District Superintendent of Police/Deputy Commissioner of Police" shall be substituted.

**6. Amendment of FORM II.-** In FORM II appended to the said rules,-

- (i) for the existing expression "**Superintendent of Police**", the expression "**Superintendent of Police/ Deputy Commissioner of Police** " shall be substituted; and
- (ii) for the existing expression "**District Superintendent of Police**", the expression "**Superintendent of Police/ Deputy Commissioner of Police** " shall be substituted.

**7. Amendment of FORM V.-** In FORM V appended to the said rules,-

- (i) for the existing expression "The District Superintendent of Police", the expression "The District Superintendent of Police/Deputy Commissioner of Police" shall be substituted; and
- (ii) for the existing expression " **Superintendent of Police District-----**", the expression "**Superintendent of Police District -----/Deputy Commissioner of Police-----**" shall be substituted.
