It has been brought to my notice by the Demuty Accountant General, Rajasthan, Jodhaur, that a Sub-Inspector utilized the sale proceeds of debris of a building towards the construction of a new Police F Building. As per Rule 7(a) of the Treasury Manual, Denartmental Receipts cannot be utilized towards expenditure. The action of the Sub-Inspector was very irregular.

It is, therefore enjoined upon all Police Officers that they should not utilize the departmental receipts towards expenditure in contravention of the aforesaid rule and that an irregularity of this kind coming to notice in future will be taken severe notice of.
