STANDING ORDER NO. 3 /1964

SUBJECT:- PROMOTION OF HEAD CONSTABLES CIVIL POLICE TO  
THE RANK OF SUB-INSPECTORS CIVIL POLICE  
(EXCLUDING PROSECUTION).

\*\*\*\*

The Board for promotion of Head Constables to the rank of Sub-Inspectors in C.P. shall be constituted by the following:-

(i) Dy. I.G. of Police of the Range: CHAIRMAN.

(ii) Two Superintendents of Police nominated by the I.G. of Police (One of these should be from outside the Range). MEMBERS.

2. This Board shall select officers for under-going Promotion Cadre Courses by conducting a Qualifying Examination which shall carry 150 marks and after examination of service records and interview which shall carry 100 marks. Details of the subjects for qualifying examination as well as for examination of service record and interview are given in Appendix Z A.

3. Those who secure 33% or more marks in written and parade tests respectively and 40% or more in aggregate shall be called for interview and examination of record which shall carry 100 marks as stated above.

4. i) No Head Constable who secures less than 40% marks in the Record and Interview and less than 45% in aggregate shall be recommended by the Board for Promotion Cadre Courses.

ii) The number of persons recommended for promotion Cadre Courses shall be the number of vacancies likely to occur plus 20%.

5. Conditions for eligibility for appearing in these tests shall be as laid down in the Schedule of Rajasthan Police Sub-ordinate Service Rules, 1963.

6. Questions papers shall be set by Officers nominated by Dy. I.G. of Police concerned. Written and parade tests and interview shall be carried out at the Headquarters of the Range concerned. Answer Books shall be examined and written tests shall be held by the Board with the help of such officers as the Chairman of the Board may deem fit.

7. Dy. I.G. of Police concerned shall fix the dates and time for these examinations which shall take place every year in November. Persons recommended by the Board as mentioned in para 5 above shall be required to undergo Promotion Cadre Courses as envisaged in sub-rule (5) of Rule 22 of the Rajasthan Police Sub-ordinate Service Rules 1963.

8. This order is being issued in accordance with rule 24 of the Rajasthan Police Sub-ordinate Service Rules 1963.

9. This order supersedes all previous orders in this regard.

Training. (10 Marks).

One mark for each of the following Courses (Total not to exceed 10 marks)

- ii) Traffic Training.
- iii) First Aid Course.
- iv) M.O.B. Training Course.
- v) Refreshers Course.
- vi) Any other training course sponsored or recognised by the I.C.P.

Good and Bad Entries. (30 Marks)

- i) One mark for each CC with cash reward.
- ii)  $\frac{1}{2}$  mark for each CC without cash reward, or cash reward only.

From the total marks so obtained, deductions shall be made as under:

- iii) One mark for each major punishment.
- iv)  $\frac{1}{2}$  mark for each minor punishment excepting Extra Drill and F.D.

After the deductions, the balance should be within a Maximum of 30 marks.
