## STANDING ORDER NO. 6 /82.

SUB:- INSPECTIONS TO BE CARRIED OUT BY CID SSB OFFICERS.

Reference is invited to Standing Order No. 4/82 issued vide this office letter No. N8(1)101(A)Gupt/69/1112-1650 dated 21.5.82, laying down a schedule of minimum inspections to be carried out by various officers of the Police Department. The following further instructions and charter of inspection of various units are issued for necessary action and guidance of CID (SSB) Officers:-

1). By Addl. IGP CID (Crimes & Intelligence) (II) Rajasthan:-

- i) Any Office/Offices under his control as deemed fit by him. Once a year.
- ii) Any District/Bn. of the Police Department on behalf of the IGP, as per orders of the IGP Rajasthan. -do-

2). By DIG CID (INT) Rajasthan, Jaipur:-

- i) His Own Office. Once a year.
- ii) Zone Offices. -do-
- iii) Border Intelligence Offices. Any 2 in a year.
- iv) District Special Branches. At least 7 in a year, one from each Range.

  - a) Office of the SP SSB:  
Half Sections of SSB. Once a year.
  - b) Office of SP (Security):  
Half Sections of Security. -do-
  - c) Office of S.S.P. (INT)  
Kota/Bikaner and SP Zone Jodhpur:  
Any two office out of three office. -do-
  - d) All Airport Security Cells at Jaipur, Jodhpur, Udaipur & Kota. -do-

3). By SP CID SSB Rajasthan, Jaipur:

- i) His Own Office. Once a year.
- ii) Zone Offices (Jaipur, Jaipur-Rural, Ajmer and Udaipur). -do-
- iii) DSBs (Jaipur, Sikar, Nagaur, Tonk, Jhunjhunu, Ajmer, Bhilwara, Chittorgarh, Udaipur, Banswara, Dungarpur and GRP Ajmer). Any six in a year.
- iv) Zone Units (Sikar, Jhunjhunu, Khetri, Tonk, Nagaur, Bhilwara, atleast two from each Kishangarh, Beawar, Chittorgarh, Zone. Banswara and Dungarpur). Any six in a year.

4). By SP (Security) Rajasthan, Jaipur:

- i) His Own Office. Once a year.
- ii) Central Interrogation Centre, -do-
- iii) Jaipur. -do-
- iv) All Airports at Jaipur, Jodhpur, -do-

Udaipur, Kota. (It should be detailed and thorough). Once a year.

5) By SP CID (INT) Kota:-

- i) His Own Office. Once a year.
- ii) Zone Office, Kota. -do-
- iii) DSBs in Zone, Kota. -do- (Kota, Bundi, Jhalawar, Sawai Madhopur, Alwar, Bharatpur and Udaipur).
- iv) Zone Units in Zone Kota. All ZUs once a year. (Bundi, Jhalawar, Rawatbhata, Sawai Madhopur, Alwar and Bharatpur).

6) By SP CID INT, Bikaner:-

- i) His Own Office. Once a year.
- ii) Border Intelligence, Ganganagar -do-
- iii) Zone Office, Bikaner. -do-
- iv) DSBs in Zone Bikaner / BI Ganganagar -do- (Churu, Bikaner, Ganganagar).
- v) Zone Units in Bikaner and BI Ganganagar: (Churu, Hanumangarh and Ganganagar). All ZUs once a year.
- vi) BI (FI, CI) Posts 50% from each BI once a year. (Total 15 posts in BI Bikaner, Ganganagar).

- iii) All ZUs in their concerned Zone. -do-
