CIRCULAR No SC

The following instructions are laid for the guidance of all concerned and it is expected that they will be followed strictly. In case of non-compliance a serious view will be taken:-

## 1. BORDER INCIDENTS.

- (a) The F.I.R. in the case of border incursions should immediately be followed by continuation report after visiting the seene of occurrence by the local Police giving true picture and facts that may be then come to the knowledge of the investig ting officer. The urgency of sending a report immediately after the F.I.R. hardly needs being emphasized as this subsequent report will save the Govt. from being placed in an embarrassing position due to any wrong information that may have been conveyed through the F.I.R.
- (b) The proceedings of the border meetings held by the Distt. Ss.P. are not quickly communicated to the Govt. but are inordinately delayed. The minutes of such meetings should be immediately sent direct to the Home Secretary within a week from the date on which held and a copy sent to D.I.G., CID.

## II. PASSPORT.

- (a) Verification of Passport Applications and work relating there-to, majority of which is from Pakistan, is not expeditiously done. In order to get it expedited it is suggested that such matter pertaining to Jaipur and Jodhpur proper will be attended by the respective Zone Officers and at other places by the Distt. Intelligence Branches. The verification will be immediately done and report sent to the Govt. within a fortnight.
- (b) The verification of applications by the Military and Bolice personnel of Pakistan for visiting India should be completed and sent to the Govt. Within three weeks from the date of receipt alongwith the comments and views of local Ss.P. who will receive such applications direct from the Govt. No. delay is to be caused at any cost as the Govt. of India is to be intimated in this connection. The cases of those who are not residents of Rajasthan may be reported back to the Govt. accordingly without loss of time.

## (c) CASES OF LONG TERM VISAS.

It has been noticed that people from Pakistan visiting Rajasthan on valid passports are generally in the habit of applying for extention, a short time before the expiry of their visas on one or the other pretext and the Ss.P. concerned cause unnecessary delay in their disposal. In order to discourage such applications and to make them leave India within the period allowed such applications after due enquiry and remarks by the Ss.P. should be immediately sent to the Govt. for disposal before the expiry of the period of the original visa.

## III. FOREIGNERS.

The matter pertaining to foreigners do not receive proper attention. Engine Instances have come to notice where foreigners were allowed to stay in India without the renewal of their residential permits. The Central Govt. is the final authority to renew such permits and it takes a serious notice of such irregularities. The Govt. has therefore desired that a thorough scrutiny of all the foreigners residing in Rajasthan may be immediately under taken and such cases brought up to date. This work should be completed within a month and a certificate to this effect sent to D.1.G., C.1.D., to enable him to intimate the Government.
