Notification

In exercise of the powers conferred by section 10 of the Rajasthan Cinemas (Regulation) Act, 1952 (Act No. 30 of 1952), the State Government hereby makes the following rules further to amend the Rajasthan Cinemas (Regulation) Rules, 1959, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Cinemas (Regulation) (Amendment) Rules, 2017.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Amendment of rule 74.- In rule 74 of the Rajasthan Cinemas (Regulation) Rules, 1959, hereinafter referred to as the said rules, after the existing clause (xi), the following new clause (xii) shall be added, namely:-
- "(xii) Three percent of the total seats in each cinema hall shall be reserved for the persons with disability. These seats shall be clearly earmarked by the cinema hall management. The seats so reserved shall be as far as possible close to the entry and exit of hall. These seats shall remain reserved for use on payment till thirty minutes before the start of the show, after which, if any seat remains vacant, such vacant seat shall be treated as unreserved."
- 3. **Amendment of FORM(C).-** In form (C) of the said rules, after the existing condition number (16), following new condition number (17) shall be added, namely:-
- "(17) Three percent of the total seats in each cinema hall shall be reserved for the persons with disability. These seats shall be clearly earmarked by the cinema hall management. The seats so reserved shall be as far as possible close to the entry and exit of hall. These seats shall remain reserved for use on payment till thirty minutes before the start of the show, after which, if any seat remains vacant, such vacant seat shall be treated as unreserved."
