- 2. Cases falling in the category as laid down under Rules of Business will be submitted to the undersigned through Additional Chief Secretary, Home/Chief Secretary/State Home Minister.
- 3. Matters required to be presented before Cabinet as per Rule 17 of Rules of Business will be submitted to the undersigned through HS/ACS/CS/MOS.
- 4. All policy matters relating to the Department will be brought to the notice of MOS/HM depending upon the importance of the matter.
- 5. All cases considered important by the Secretary, Home/Secretary Home (Law)/Joint Secretary/Sr. Deputy Secretary/Deputy Secretary/Group Officer will be brought to the notice of the Additional Chief Secretary, Home.
- 6. Cases ordinarily to be disposed of by the Minister (Home) will be disposed by MOS, in the absence of the HM from the headquarters, provided that the case is of such a nature that it cannot await the arrival of the HM. However, such decisions should be confirmed by the HM later on. Similarly, when ACS is out of station or out of office then files where decision is to be taken at MOS/HM level, will be submitted by SHL/HS directly to MOS/HM, as the case may be.
- 7. Cases to be disposed of by HS, in his/her absence, will be disposed of by ACS.
- 8. In respect of appeals under RSC (CCA) Rules, 1958: -
 - I. Constable to ASI in Police Deptt. Opportunity of being heard in the appeals under CCA Rules will be afforded by JS concerned and final orders shall be passed by him only.
 - II. Constable to Platoon Commander-Opportunity of being heard in the appeals under CCA Rules will be afforded by JS concerned and final orders shall be passed by him only.
 - III. Sub-Inspector/ PC in Police Deptt.- Opportunity of being heard in the appeals under CCA Rules will be afforded by HS concerned and final orders shall be passed by him.
 - IV. Inspector / CC in Police Deptt.- Opportunity of being heard in the appeals under CCA Rules will be afforded by ACS and final orders shall be passed by him.
- 9. Cases not covered by the above items will be examined by Group Officer and put up to MOS/HM through ACS for orders.
