 - (ii) Company Commander in Home Guard Deptt., Opportunity of being heard in the appeals under CCA Rules will be afforded by Secretary, Home and final orders shall be passed by him.
 - (iii) Jailor, Opportunity of being heard in the appeals under CCA Rules will be afforded by Secretary, Home and final orders shall be passed by him.
- 9. Matter of Accounts (Group-II) related to Home Guards will be routed through JS(Group-VII) and those related to Group-XII-Jail will be routed through DS/ JS (Jail).
- 10. Cases not covered by the above items will be examined by Group Officer and put up to HM through PSH for orders.
- All the officers may ensure that the compliance of Administrative Reforms (Group -1) Department Order F. 6(2)AR/Gr.1/14 dated 17-03-2015.
