- Cases ordinarily to be disposed of by PSH in the absence of the 6. Minister from the headquarters provided the case is of such a nature that it cannot await the arrival of the Minister. But such decision should be brought to the notice of The Minister later on.
- 7. Similarly, Group Officer in the absence of Dy. Secretary may dispose of urgent cases.
- Opportunity of being heard in the appeals under CCA Rules will 8. be afforded by the Dy. Secretary/OSD concerned and submitted to HM through PSH.
- Cases not covered by the above items will be examined by Group 9. Officer and put up to MOS through PSH for orders.
