



- 3. Matters required to be presented before Cabinet as per Rule 17 of Rules of Business will be submitted to Chief Minister through HS/ACSH/CS.
- 4. All policy matters relating to the Department will be brought to the notice of Additional Chief Secretary, Home.
- 5. All cases considered important by the Secretary, Home/ Special Secretary Home (Law)/ Joint Secretary/ Sr. Deputy Secretary/ Deputy Secretary/ Group Officer will be brought to the notice of the Additional Chief Secretary, Home.
- 6. Cases ordinarily to be disposed of by the Minister (Home) will be disposed by ACSH, in the absence of the HM from the headquarters, provided that the case is of such a nature that it cannot await the arrival of the HM (Home). However, such decisions should be confirmed by the HM later on. Similarly where ACSH is out of station or out of office cases, to be decided by HM, will be submitted by SSHL/HS directly to HM.
- 7. Cases to be disposed of by HS, in his absence, will be disposed of by ACSH.
- 8. In respect of appeals under CCA Rules:

- (i) Constable to ASI in Police Deptt. Opportunity of being heard in the appeals under CCA Rules will be afforded by JS concerned and final orders shall be passed by him only after approval of SSH.
- (ii) Constable to Platoon Commander Opportunity of being heard in the appeals under CCA Rules will be afforded by JS concerned and final orders shall be passed by him only.
- (iii) Jail Warden to Dy. Jailor Opportunity of being heard in the appeals under CCA Rules will be afforded by HS concerned and final orders shall be passed by him.
- (iv) Sub-Inspector/ PC and Circle Inspector / CC in Police Deptt.- Opportunity of being heard in the appeals under CCA Rules will be afforded by HS concerned and final orders shall be passed by him.
- (v) Company Commander in Home Guard Deptt.- Opportunity of being heard in the appeals under CCA Rules will be afforded by HS concerned and final orders shall be passed by him.
- (vi) Jailor- Opportunity of being heard in the appeals under CCA Rules will be afforded by HS concerned and final orders shall be passed by him.
- 9. Matter of Accounts (Group-II) related to Home Guards will be routed through JS(Group-VII) and those related to Group-XII-Jail will be routed through DS/ JS (Jail).
- 10. Cases not covered by the above items will be examined by Group Officer and put up to HM through ACSH for orders.
- 11. All the officers may ensure that the compliance of Administrative Reforms (Group -1) Department Order F. 6(2)AR/Gr.1/14 dated 17-03-2015.
